Focus & engagement • Sit, down & stand • Loose-leash walking • Stay & impulse control • Recall • Everyday manners • Working around distractions

WHAT TO BRING

Standard 6-foot leash (no retractable leashes) • Plenty of small, high-value treats • Your dog's personal water bowl • Poop bags

Please bring your dog's own water bowl so bowls are not shared between dogs. Water may be available for refills.

CLASS EXPECTATIONS

Dogs remain leashed unless otherwise instructed. Please give other teams space and avoid dog-to-dog greetings before, during, and after class. This is a training class, not a dog play group.

Dogs displaying aggression toward people or other dogs will need one-on-one private training with Bowman & Co. Canine Training rather than participating in the group class.

PARTICIPANT RESPONSIBILITIES

I agree to maintain control of my dog, follow all Havana Park District rules, class rules, and instructor directions, use appropriate equipment, and provide accurate information about my dog's behavior. I understand that dogs must remain leashed unless specifically instructed otherwise and that dog-to-dog greetings are not permitted during class activities.

BEHAVIOR DISCLOSURE

I agree to disclose any known bite history, attempted bites, aggression, or other behavior that could affect the safety of participants, dogs, instructors, Park District personnel, or the public. I understand that a dog may be determined unsuitable for the group setting and may be directed to one-on-one private training.

RELEASE AND HOLD HARMLESS

To the fullest extent permitted by applicable law, I release and hold harmless Havana Park District, its commissioners, employees, & instructors, and Bowman & Co. Canine Training, Sasha Bowman, and their agents or representatives, from claims arising from the ordinary inherent risks of participation in this dog-training program, and in consideration for the HPD providing these activities, do release the HPD & it's staff/instructors from all liability for any injuries sustained while on HPD property &/or participating in any HPD activities.
